I responded to said area for back-up. Upon making contact with the white male driver, he was advised that he was being stopped because his vehicle was observed and was identified as leaving the scene of a crash with property damage and bodily injury to a person. I then detected a strong odor of an alcoholic beverage emitting from his breath. The subject's speech was slurred, his eyes were blood shot and he had a difficult time retrieving his driver's license from the pocket of his swimming trunks. While speaking with the white male subject, I observed the straw hat on the passenger seat of said vehicle that was described in the BOLO. The subject then produced his Florida DL and he was positively identified as, Justin Rakin Burson. Justin continued to look for his registration and insurance card; however, he was unable to locate said documents.

I then advised Officer Koller that Officer Carroll and I were out with the subject fitting the description of the hit-and-run. I also advised Officer Koller that I would be conducting a D.U.I investigation.

Officer C. McClure #28 then responded to our location with several witnesses who independently, positively identified Justin as the driver that struck several vehicles and a pedestrian.

I then advised Justin that our traffic crash at this present time was complete and that he was identified as the driver that left the scene of the crash. I also advised him that I would be conducting a D.U.I investigation due to the strong odor of an alcoholic beverage emitting from his breath and him showing signs of impairment.

I then asked Justin if he would perform the Standardized Field Sobriety Exercise (SFSE) to determine if he was capable of operating a motor vehicle. Justin continued to be argumentative and continued asking why he was being stopped. Justin denied ever being involved in any vehicle crash or even striking a pedestrian. Justin declined to perform the SFSE. I then read implied consent to Justin; however, he declined to perform any SFSE or submit to a standard breath test. Justin was placed under arrest.

I was then advised by Officer Koller that the pedestrian that was struck was seriously injured and being transported to Cape Canaveral Hospital. A short time later, it was confirmed that the victim had died from the injuries sustained in this crash.

I then transported Justin to Cape Canaveral Hospital for a forced blood draw, and to be medically cleared.

I was later informed by Officer McClure, that Justin and the victim became involved in a verbal dispute and the victim began to hang onto the driver's side door of Justin's truck as he was backing out of a parking space. Justin continued to pull out onto SRA1A while the victim was still hanging onto the truck and crashed into a northbound vehicle. The impact of the crash caused the victim to fall under the truck where he was run over by the wheels of said truck. Justin continued north on SRA1A, failing to stop and render aid, and was subsequently stopped by Officer Carroll. Justin was transported to the Cocoa Beach Police Department where he was booked and then transported to the Brevard County Jail.
