On July 10, 2013, at approximately 2341 hours, the Melbourne Police Department received a 911 call from the victims, Michael Augenti and Jenny Medeiros, advising multiple suspects entered their home and shots were fired.

Investigation revealed multiple suspects arrived in the area armed with firearms and enter the backyard of the victim's residence by jumping over a wooden privacy fence. Suspects then enter the residence through the back door and were confronted by the residents/victims. Medeiros yelled for Augenti and jumped for cover to the couch in order to protect their 18 month old daughter while Augenti came to the front door from the front porch. Augenti, hearing the screams from Medeiros and confronted by three unknown black male suspects wearing masks/coverings over their faces, unholstered his firearm, which he carries on him and has a permit/license for, and began firing towards the suspects.

The suspects fled out the rear and the victim's ran to a neighbor's for safety, calling 911. Three suspects were located when they arrived at Holmes Regional Medical Center (HRMC) to drop off the defendant, Bobby Culler, who was suffering from a gunshot wound. All three were detained and subsequently placed under arrest.

Investigation revealed the defendant was the lead suspect entering the residence, wearing a mask and armed with a handgun held up and pointed forward. The defendant made it into the middle of the home (living room), just a couple feet from Medeiros who was running away, screaming for help, and then jumping to the couch to protect her 18 month daughter who lay sleeping, before he was confronted by Augenti and gunfire. The defendant was struck by gunfire and fell in the kitchen area where he dropped his handgun, then continued to flee through the rear of the residence. After the defendant fled back to the vehicle, he was then dropped off at HRMC where he was located and detained. The defendant identified himself to police and hospital staff as Brandon Harris, continuing to do so as he was admitted to the hospital and treated by staff. It was later confirmed that his true identity was Bobby Culler, who had an active warrant. Culler was arrested and held under the active warrant.

A computer check revealed the defendant is a convicted Felon with an extensive criminal history. The defendant has multiple felony convictions, most recent being an Armed Robbery case 052010CF061489AXXXXX - 18th Circuit Court - Viera.

On July 12, 2013, at approximately 1530 hours, the defendant was released from HRMC and a post-Miranda interview was attempted prior to being transported to the Brevard County Jail for his active warrant, however, the defendant advised he did not wish to speak without a lawyer present. The defendant was turned over to Jail.

At this point in the investigation, I have probable cause to believe the defendant committed the above listed offenses. Charges are supported by sworn witness testimony. This arrest affidavit was completed and delivered to the Jail where the defendant would be booked.
