On 10/09/13, at approximately 1540 hours, agents of the Brevard County Sheriff's Office (BCSO) Gangs & Violent Crimes Task Force (GAMEOVER) were searching for Wade Dante Jackson, herein referred to as 'Defendant,' regarding an active felony arrest warrant. Agents located Defendant sitting in the front passenger seat of an otherwise unoccupied vehicle parked in a parking space at the apartment building located at 399 Herring Street, Melbourne, Brevard County, Florida.

GAMEOVER agents made contact with defendant by surrounding the vehicle with multiple unmarked BCSO patrol vehicles, exited, and approached Defendant on foot. All agents were clearly recognizable as law enforcement officers as they were wearing external ballistic vests complete with patches with the word "SHERIFF" marked in large, yellow block lettering on the front and back, visible firearms holsters, and badges. Agents repeatedly issued clear, loud verbal commands to Defendant to exit the vehicle with his hands up. Defendant ignored agents' orders, and refused to exit the vehicle. Defendant then locked the vehicle doors, and quickly climbed into the driver seat. He continued to disobey agents' orders to exit the vehicle and shifted the vehicle into a forward gear, accelerated sharply which caused him to crash into the front porch area of the apartment building. Unable to continue forward, Defendant then placed the vehicle in reverse and accelerated rapidly and violently in the direction of three agents. This action caused the agents to believe their physical safety was in imminent danger, and forced them to jump out of the way to avoid being struck by the vehicle. Defendant was able to maneuver between multiple law enforcement vehicles and continued to drive in reverse northbound on Herring Street at a high rate of speed for approximately two city blocks until reaching the intersection with Brevard Avenue. Defendant then turned the vehicle around and proceeded eastbound until he reached the intersection with Babcock Street, where he began to lose control of the vehicle, swerving violently several times into oncoming traffic, before coming to a stop near the residence located at 10 Crescent Avenue. Defendant then exited the vehicle and began to flee on foot southbound through the backyard of the residence. As agents began to pursue Defendant on foot, they immediately located a semi-automatic handgun on the ground approximately 6 feet from the vehicle in the location that Defendant jumped the fence into the backyard. Pursuing agents discovered the rear door of the residence had been forced open, and subsequently surrounded the residence. Three residents of the home were inside when Defendant forced entry. Agents were eventually able to evacuate the three occupants (adult male, adult female, and male juvenile) out of the residence for their safety.

A containment perimeter was established around the residence and the Melbourne Police Department (MPD) Special Weapons and Tactics (SWAT) Team responded to the scene. During the approximate 6 hour standoff, SWAT operators attempted verbal contact with Defendant, which included the use of a tactical robot, and the use of tear gas. After these efforts were met with negative results, SWAT operators made entry into the residence and located Defendant hiding inside a bedroom closet, where he was arrested without further incident.

A search of the vehicle Defendant had been driving resulted in the location of a plastic bag containing 5.0 grams of suspected cocaine base in the front-passenger door pocket next to Defendant's cellular telephone. A second plastic bag containing 1.0 grams of suspected cocaine base was located on the driver floorboard, as well as a plastic bag containing 1.0 grams of suspected cannabis. Subsequent field tests confirmed their identities as such. Agents also located a backpack containing a cocaine-base cooking kit, which included several items with cocaine residue on the rear passenger floorboard.

An FCIC inquiry confirmed Defendant's Florida driver license and driving privilege is presently revoked regarding multiple indefinite suspensions regarding failures to pay traffic fines, failures to appear for traffic summons, most recently on 09/04/2012, regarding failure to pay a court financial obligation.

It should be noted that Defendant is presently released from the Brevard County Jail Complex on felony bond regarding Brevard County Clerk of Courts case number 2013CF053616, which also included charges of Aggravated Assault upon a Law Enforcement Officer with a Firearm.
