ASSISTANT STATE ATTORNEY, CHARGES THAT:

COUNT 1: IN THE COUNTY OF BREVARD, STATE OF FLORIDA, on October 9, 2013,
WADE DANTE JACKSON, did unlawfully enter a dwelling, located at 10 CRESCENT DRIVE,
MELBOURNE, FL, the property of JASON CUMMINGS, LISA CUMMINGS, as owner or
custodian, with the intent to commit an offense therein, contrary to Sections 810.02(1)(b),
810.02(3), 810.07, Florida Statutes,

COUNT 2: IN THE COUNTY OF BREVARD, STATE OF FLORIDA, on October 9, 2013,
WADE DANTE JACKSON having previously been convicted of a felony, did own or have in
his care, custody, possession, or control a firearm, and during the commission of said offense,
WADE DANTE JACKSON actually possessed a firearm or destructive device as those terms are
defined in Section 790.001, Florida Statutes, contrary to Sections 790.23(1), 790.23(3),
775.087(2)(a)1, Florida Statutes,

COUNT 3: IN THE COUNTY OF BREVARD, STATE OF FLORIDA, on October 9, 2013, WADE DANTE JACKSON did, in the course of unlawfully leaving or attempting to leave the scene of a crash in violation of section 316.027 or section 316.061, having knowledge of an order to stop by a duly authorized law enforcement officer, RICHARD CLEMENTS, DEREK CHEEK, willfully refuse or fail to stop in compliance with such order, or having stopped in knowing compliance with such order, willfully flee in an attempt to elude such officer; and as a result of such fleeing or eluding, cause injury to another person or damage to any property belonging to another person, MUKESH GAGLANI, EURIPIDES RODRIGUEZ, WASTE MANAGEMENT, contrary to Section 316.1935(4)(a), Florida Statutes,

COUNT 4: IN THE COUNTY OF BREVARD, STATE OF FLORIDA, on October 9, 2013, WADE DANTE JACKSON did, with a deadly weapon, to wit: MOTOR VEHICLE, without intent to kill, knowingly commit an aggravated assault upon a law enforcement officer, RICHARD CLEMENTS, while said law enforcement officer was engaged in the lawful performance of said officer's duties, by intentionally making an unlawful threat, by word or act, to do violence to the person of said officer, coupled with an apparent ability to do so, and doing some act which created a well-founded fear in said officer that such violence was imminent, knowing that RICHARD CLEMENTS was a law enforcement officer, contrary to Sections 784.021(1)(a), 784.07(2)(c), 775.082(3), Florida Statutes,



COUNT 7: IN THE COUNTY OF BREVARD, STATE OF FLORIDA, on October 9, 2013, WADE DANTE JACKSON did knowingly and willfully resist, obstruct, or oppose an officer, or officers, RICHEARD CLEMENTS, CHRISTOPHER GALLO, DEREK CHEEK, of the BREVARD COUNTY SHERIFF'S OFFICE, in the execution of legal process or the lawful execution of a legal duty, by offering or doing violence to the person of said officer or officers, contrary to Section 843.01, Florida Statutes,

COUNT 8: IN THE COUNTY OF BREVARD, STATE OF FLORIDA, on October 9, 2013, WADE DANTE JACKSON, being a person whose driver's license or driving privilege had been canceled, suspended or revoked as provided by law, and who, knowing of such cancellation, suspension, or revocation, did drive a motor vehicle upon the highways of this state while such license or privilege was canceled suspended or revoked, contrary to sections 322.34(2)(a), 322.34(10)(a), Florida Statutes, and further, at the time, WADE DANTE JACKSON had previously been convicted of Driving While License Canceled, Suspended or Revoked in case or citation number 2007-MM-54594, in BREVARD County, Florida, contrary to sections 322.34(2)(b), 322.34(10)(a) and 322.34(10)(b)2., Florida Statutes,

AND against the peace and dignity of the State of Florida.

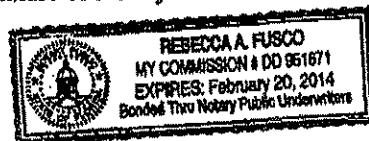
